Students who live more than 40 km from an exam centre may write their exam closer to home provided they arrange for a suitable invigilator who meets the invigilator guidelines, and who is willing to invigilate their exam. 	Invigilators:	An invigilator is an individual who is authorized to supervise the writing of an exam by an AU student. AU reserves the right to reject proposed invigilators, or discontinue the use of an invigilator.				
	Invigilator Guidelines:	Examinations must be written under the supervision of an AU-approved invigilator at an AU-approved invigilation centre. To eliminate conflicts of interest—relatives, friends, neighbours, co-workers (including immediate supervisors), persons living at the same address as the student or other AU students—cannot invigilate examinations without the				

student exams. Students are responsible for all expenses incurred for this service.
